Notification Regarding Pending PhD Semester Course Fees

This is to inform all PhD scholars enrolled under various departments of Auniati University that many scholars have outstanding Semester Course Fees. The fee structure for scholars enrolled across two academic sessions is mentioned below.

All scholars who have not yet paid their fees are hereby requested to deposit the outstanding amounts on or before 25th September 2025. This is crucial as the PhD title registration process for the 2024-2025 session scholars has already commenced. To ensure timely progression to subsequent stages, it is imperative that they clear their first and second semester course fees promptly. Upon payment, these scholars will become eligible to initiate their pre-submission process within the upcoming year.

Furthermore, scholars of the 2025-2026 session who have appeared in the Course Work examination must submit proof of payment for the admission fees of ₹20,000 and the first semester course fees of ₹50,000 to the PhD Course Coordinator by 15th September 2025, depositing these amounts into the university's designated account.

Please note that any PhD scholar with unpaid fees will have their examination results withheld. Scholars are urged to comply with the above deadlines to avoid any academic or administrative delays.

The fee payment details by batch are as follows:

- (a) Scholars enrolled under the University PhD Regulation Rule 6.0, Sub-Rule 6 during the 2024-2025 academic session must first deposit admission fees of ₹7,000 and first semester course fees of ₹50,000. Following this, they are required to pay the second semester course fee of ₹50,000 along with the third semester course fee of ₹50,000 and second-year admission fees of ₹7,000.
- (b) Scholars enrolled under University PhD Regulation Rule 6.0, Sub-Rule 5 during the 2024-2025 academic session must deposit admission fees of ₹20,000 and first semester course fees of ₹50,000 initially, followed by the second semester course fee of ₹50,000.
- (c) Scholars enrolled under University Regulation Rule 6.0, Sub-Rule 6 for the 2025-2026 academic session must deposit admission fees of ₹20,000 followed by the first semester course fees of ₹50,000.
